The *South Australian Skills Act 2008* (the *SAS Act*) states that the Nominated Training Organisation (NTO) must notify the Commission that a training plan has been endorsed by each of the parties 28 days after accepting a nomination to be the NTO for a Training Contract.

If the NTO is unable to prepare (and obtain the necessary endorsement of) a Training Plan within this timeframe, it must complete and submit this form to apply for an extension of time, at least five business days in advance of the 28-day deadline.
